Irvine voters are plainly fed up with (unelected) Mayor Christina Shea and (unelected) Councilman Michael Carroll and their developer-controlled Council majority. These angry voters are now employing the tools of direct democracy to put things back on track in Irvine.

The "Build the Great Park Veterans Cemetery" citizens' initiative petition — and the two recall petitions against Shea and Carroll — are in direct response to the latest Shea-Carroll corrupt scheme. or weeks, scores of Irvine volunteers have been circulating three official voter petitions: the "Build the Great Park Veterans Cemetery" initiative petition and two recall petitions.

The recall petitions are aimed at Mayor Christina Shea and Councilman Michael Carroll.

An Open Letter

In an open letter to Irvine residents, Ed Pope, chair of the Build the Great Park Veterans Cemetery committee, put it this way: "After enduring five years of Christina Shea's deliberate delays and her self-described 'diversion' schemes to defeat our long-planned Veterans Cemetery, Irvine citizens are finally gaining the upper hand in the fight to establish a beautiful Veterans Memorial Park & Cemetery as part of our Great Park."

Initiative

Pope cited the Veterans Cemetery initiative, authored by Larry Agran, former Mayor and public interest attorney. If the initiative is adopted by Irvine voters, it will override any Council scheme to give control of the

City-owned, 125-acre "ARDA" site at edge of the Great Park to developer FivePoint for commercial and industrial development. The initiative will further guarantee that the property can only be used for a State-built, State-operated Veterans Memorial Park and Cemetery.

Two Recalls

In his open letter, Pope further declared: "To ensure that the Veterans Cemetery actually gets built right away — with no more political games to sabotage the project — our committee to Build the Great Park Veterans Cemetery is endorsing and supporting the citywide effort to recall (unelected) Mayor Christina Shea and her hand-picked (unelected) Councilman Michael Carroll."

To qualify the two recalls and the Veterans Cemetery initiative for the ballot later this year, petition circulators must gather nearly 15,000 Irvine voter signatures on each of the two recalls and the Veterans Cemetery initiative. ICNV



Taking Matters Into Our Own Hands

uring the November and December holiday season (when they thought that nobody was paying attention) the Irvine City Council's two unelected members — Mayor Christina Shea and Councilman Michael Carroll — pushed ahead with yet one more corrupt land-use scheme. The two set out to derail and defeat the long-planned Veterans Memorial Park & Cemetery at the Great Park "ARDA" site, and hand control of the valuable City-owned property to a billion-dollar commercial developer.

At the November 26, 2019 City Council meeting, two days before Thanksgiving, Shea and Carroll put forward their scheme to rezone the City-owned, 125-acre ARDA site at the Great Park. Their zoning ordinance replaced the long-planned, pastoral Veterans Memorial Park & Cemetery with zoning for massive office, commercial and industrial development intended to net hundreds of millions of dollars for their favorite developer, FivePoint.

But wait a minute! Armed with the power of initiative, Irvine citizens don't have to accept this kind of local greed and corruption. In fact, we have the power to draw up our own zoning ordinance, gather enough initiative petition signatures, and put our own plan on the ballot for Irvine voters to approve.

And, that's exactly what we're doing. I am the author and official proponent of the "Build the Great Park Veterans Cemetery" initiative — the people's zoning ordinance to once-and-for-all require that the 125-acre ARDA site be used solely and exclusively for a State-built and State-operated Veterans Memorial Park & Cemetery. This initiative would override the Shea-Carroll-FivePoint zoning and any other schemes intended to defeat the Veterans Cemetery project.


Of course, our initiative requires sustained public support to succeed — first to gather the necessary 15,000 Irvine voter signatures to qualify for the ballot, and then a majority of

Irvine voters saying YES at the ballot box in November.

So, let's join together in taking matters into our own hands. Let's urge every Irvine voter to support the initiative. Just say YES with a signature and by voting YES later this year.

A YES vote will not only override the Shea-Carroll-FivePoint rezoning scheme, it means that we can begin demolition and site cleanup this year — as the first step in a 30-month construction schedule for the beautiful Statebuilt and State-operated Veterans Memorial Park & Cemetery. YES, let's do it!

An ICNV Feature Series On Healthful Living As We Age

Volunteering = Better health ... at any age

ome people in their 80s and 70s — and sometimes even younger - claim they are too tired or too debilitated to participate in activities and volunteer for community causes. I recently interviewed three people for this article who believe otherwise — that it's just a matter of desire and will, and that the benefits of civic activism are great regardless of any mobility limits you may have.

Ed McNew, 87-year-old retiree

Ed McNew is an 87-year-old retired businessman, a U.S. Army veteran, and a 47-year resident of Irvine who now gets around with a walker that also can serve as a chair. He is the top signature gatherer for the "Build the Great Park Veterans Cemetery" initiative petition. Ed spends about 6 hours each day, 6 or 7 days every week, sitting

at a table, collecting the signatures of passersby at various locations throughout Irvine. He seems to be a natural at attracting people who stop to

Once stopped, Ed engages them in a brief conversation that often leads to their signing the petition; or, they just move on.

Ed says, "I'd rather be out collecting signatures than be home sitting in front of the TV or reading. I'm extremely disappointed in our current City Council." Ed explained, "I feel strongly that we must have a Veterans Cemetery. And having been in the military, I want to support this cause to the best of my ability. This gives me purpose, and it's something I look forward to every day."

Ed's wife of 60 years passed away two years ago, and he clearly finds fulfillment in his efforts. In fact, when Ed began collecting signatures, he was assigned a location every other day, thinking that to do more would be "too much." However, soon after he began collecting signatures, he insisted on being assigned a location every day. Either his daughter or another volunteer brings him, and then picks him up at the end of his day.

Joyce Kassouf, 81-year-old retired nurse

Joyce Kassouf, 81, is a retired nurse, a long-time resident of Irvine, and a long-time civic volunteer. She walks without aid and gets around, but has some mobility issues and limited stamina, so in ways that improve our community while improving their own she takes advantage of available assistance, like a shopping cart, physical health and outlook on life, as well.

when in a market. She volunteers because "where there's a need, I get great gratification to give back." And for this particular cause she is especially passionate. "Men and women gave their lives and their youth, and it's an honor to help this cause" by qualifying the Veterans Cemetery initiative petition for the ballot. "It makes me feel good!" she said, emphatically.

Jean Anne Turner, 75-year-old retired teacher

Jean Anne Turner, 75, is a beloved, retired IUSD teacher, and Irvine's only two-time Teacher-of-the-Year award winner. She was collecting signatures at Irvine's Veterans Day event when I spoke with her. She told me she is disgusted with the City Council and called "shameful and a cheap trick" the Council's refusal to begin

building the Veterans Cemetery at the original Great Park site. Jean Anne is the daughter of a World War II veteran and the wife of a U.S. Marine. Jean Anne has been on her homeowners association's Green Belt Committee for he past 20 years. She stays active and believes "one must bloom where you're

planted and improve the quality of life of your local community!"

Ed, Joyce and Jean Anne are among our most prolific signature gatherers. They all believe strongly in the cause and clearly are helped in their outlook and state of mind by their meaningful civic activity. It's a terrific social activity that engages people, and the benefits they experience are not flukes. In striving to help our community they are engaging with hundreds of Irvine neighbors

Q: What's the purpose of the Great Park Veterans Cemetery Initiative?

Or, will developer FivePoint be given control of the site for its massive development projects?

Official Grounds for Recalling Mayor Christina Shea:

Mayor Christina Shea serves her own interests and big developers, not Irvine residents. Recently, in a backroom political deal, then-Councilmember Shea became Irvine's first unelected Mayor in the past 30 years, when former Mayor Donald Wagner resigned to become County Supervisor. In 2016, Shea benefitted from more than \$100,000 in outside campaign funding from developers to win election to the Council. Once elected, Shea promoted Measure B — the developer-backed scheme to replace the planned, designed, and CalVet-approved Veterans Cemetery on the City-owned "ARDA" site alongside the Great Park with office, industrial and other terrible traffic-inducing development. In 2018, Irvine voters overwhelmingly defeated Shea's Measure B, 63% to 37%. Yet, Shea stubbornly refuses to accept the will of the people. As Irvine's unelected Mayor, she remains determined to defeat the Veterans Cemetery at the ARDA site in favor of more unwanted development. To honor the will of the people, build the beautiful Veterans Memorial Park & Cemetery at the ARDA site, and restore integrity to the Mayor's office, Christina Shea must be recalled, removed from office, and replaced by an elected Mayor who puts the interests of Irvine residents first.

Official Grounds for Recalling Councilmember Michael Carroll:

In a backroom political deal, Christina Shea became Irvine's unelected Mayor on April 3, 2019. Six weeks later, Shea voted to appoint Michael Carroll to fill her vacated seat on the City Council. This two-step maneuver enabled Michael Carroll to become an Irvine City Councilmember without Irvine voters having any say in the matter. Since his appointment to City Council, Carroll has worked to defeat the long-planned, designed, and CalVet-approved Veterans Cemetery, which would be State-built and State-operated on the City-owned "ARDA" site alongside the Great Park. Carroll ignores the will of the people, aligning himself with Shea and developers and their scheme to replace the planned Veterans Cemetery on the 125-acre ARDA site and pave the way for massive development and added traffic. Irvine residents deserve to have an elected Councilmember who is beholden to the people rather than beholden to an unelected Mayor and billion-dollar developers. If we ever expect to see the Veterans Memorial Park & Cemetery at the ARDA site alongside the Great Park, we must recall and remove Michael Carroll from the City Council and replace him with an elected Councilmember who respects the will of the people.

We can do this! We can begin construction this year! Support the initiative and recall petitions!



SchoolWatch: by Carolyn Inmon The New Normal: Accepting the Unacceptable?

ast November 14th, yet another school shooting — this time at Saugus High School in Santa Clarita, just a two-hour drive up the I-5 — took the lives of three high school students, wounded three more, and traumatized the entire Santa Clarita community.

Do you remember that particular school shooting? Perhaps. But have you heard a follow-up news story about it recently? Probably not. It's not really "news" anymore. After all, the Saugus High School shooting "only" had 6 casualties, including the shooter, who took his own life; other school shootings have had many more killed and wounded.



The new normal

With America awash in guns and gun violence, the shocking fact is that school shootings have become the "new normal." In 2018 and 2019, the country has suffered through a combined, record-breaking total of more than 200 school shooting incidents.

For most of us not directly affected by a school shooting, it seems that the initial shock, anger, and sadness we experience lasts only a few days, and then we "move on." Apparently, as a society we have begun to accept the unacceptable, hoping that somehow "it won't happen here."

Our public schools were once thought to be the safest possible places for kids. We made sure that was the case. Here in California, we never hesitated to spend billions of dollars to ensure that school buildings are structurally sound so that students, teachers, and staff would remain safe in the event of earthquakes, fires, and other disasters.

The cost of improved security

Unfortunately, an upsurge in gun violence in public schools requires a new look at school safety. It requires us to consider expensive new security systems to improve protection against gun violence in our

schools. New security measures should include installation of carefully designed checkpoints that are effective without being offensive; and the provision of comprehensive video surveillance systems that monitor school perimeters.

Enhanced school security also requires hiring additional School Resource Officers - these are Irvine

police officers who are specially trained and assigned to school sites to patrol and otherwise protect the school community.

Of course, these measures are costly. They would require tens of millions of dollars over time...and the willingness of

Irvine taxpayers to pay for these important security improvements.

In California, school safety is a joint City-School District responsibility. I think it's time — in fact, it's past time — for the Irvine City Council and School Board to show some leadership, develop a bold

Enough is enough! Recall Shea and Carroll!

As Irvine residents, we have had enough! We have had enough of the duplicity, the political games, and the disregard for our votes and even our right to vote. We have had **enough** of the corrupting influence of developer money that funds City Council candidates at exorbitant levels. We have had enough of the Shea-Carroll-FivePoint sleazy schemes to move the long-planned State Veterans Memorial Park & Cemetery from the 125-acre Great Park ARDA site to anywhere else, so that billiondollar developer FivePoint can control that City-owned land.

There is a long history of the effort to build the Veterans Cemetery in the Great Park, beginning in 2014 with Orange County Assemblywoman Sharon Quirk Silva's introduction of Assembly Bill 1453, followed by then-Councilmember Larry Agran's resolution, adopted at the July 2014 Council meeting, designating the Great Park ARDA site for a State-built and Stateoperated Veterans Cemetery.

Regrettably, there is also a long history of Christina Shea's relentless effort to defeat the Veterans Cemetery in the Great Park, beginning with her first NO vote on the project in 2014.

Shea's objective has always been to move the planned Veterans Cemetery away from the ARDA site in order to make room for massive FivePoint development. Along the way, FivePoint spent \$106,088 to promote Shea's 2016 reelection campaign for City Council.

FivePoint Takes Over City Council

So, how did Shea become our Mayor? Answer: The City Council majority, itself, changed the Municipal Code in January 2019, so that then-Councilmember Christina Shea would become Mayor if Mayor Donald Wagner were to resign. Wagner did, indeed, resign to become Supervisor after winning a March 2019 special election. Thus, Shea became Irvine's first unelected Mayor in 30 years, leaving her Council seat vacant.

Then, 6 weeks later, unelected Mayor Shea, with developer FivePoint's help, maneuvered to have Michael Carroll appointed by the Council majority to fill her vacated Council seat.

Interestingly, Michael Carroll's wife, Betty Carroll, received \$14,000 in campaign help from FivePoint's PAC for her successful 2016 Irvine School Board run.

In the summer of 2019, Mayor Shea and appointed Councilmember Carroll led the effort to eliminate the Veterans Cemetery at the ARDA site. They then pushed to rezone the site so FivePoint could use this Great Park property to build office, commercial and

industrial projects — making hundreds of millions of dollars in profits off of our valuable parkland that was designated in 2014 for a Veterans Memorial Park & Cemetery that should have been built and operational by **now**. Shea later described this entire scheme as a "diversion tactic."

Not Our Values

In 1989, Shea first gained prominence and was later elected to our City Council when she bashed the LGBTQ+ community by leading a ballot measure campaign that successfully removed the LGBTQ+ community from protection under the City's non-discrimination ordinance. Shea told the LA Times, "I'm a mom with three kids and I don't want gay pride festivals or public sex in bathrooms in my city."

Flash forward 20 years. In June 2019, within weeks of becoming Mayor, Shea attended the annual meeting of the prestigious U.S. Conference of Mayors — where 226 U.S. mayors, on a bi-partisan basis, adopted consensus resolutions to deal with the challenges facing our cities, our country, and the world. Shea embarrassed herself and our entire City when she was one of just a half-dozen mayors to vote NO on four sensible resolutions to put cities in the forefront in combating climate change.

Shea also voted NO on all seven resolutions calling for the dignified and humane treatment of asylum seekers and other immigrants seeking refuge in the United States. Irvine, once known for our leadership on environmental issues and our welcoming attitude toward immigrants, now finds itself led by a Mayor who rejects these long-held Irvine values.

In a further affront to Irvine citizens and values, Shea teamed up with Carroll (and Councilmember Anthony Kuo) to reject a simple, routine proposal to join with many other cities in flying the rainbow-colored "Pride Flag" at City Hall — in recognition of the past 50 years of progress in overcoming discrimination against gays, lesbians and others made to suffer because of their sexual orientation. Councilmember Carroll went so far as to condemn the Pride Flag as a "spectacle of divisiveness."

Shea and Carroll Get Personal

In responses to the "grounds for recall" on the petitions for the recall that I've been leading, both Shea and Carroll chose to attack my Armenian heritage by spelling out my full birth name, Kevork Nazar Abazajian, to highlight my non-Anglo-Saxon name. You may see that when you sign the recall petitions. Shea and Carroll may as well have put "unwanted immigrant" in front of my Armenian name. I am proud of my name. My family left the Soviet Union as political refugees when I was five years old. Now, I treasure being able to participate in our free political process.

I became "Kev" Abazajian growing up in Texas, and the nickname has stuck. I earned a Ph.D in astrophysics at the University of California, San Diego, in 2001, and I'm now a full Professor at UCI as well as Director of the Center for Cosmology.

Shea and Carroll Must Go

Christina Shea and Michael Carroll are not only unelected to their Council positions, they go out of their way to disrespect and offend Irvine voters and the values we share as a community. That's just plain wrong. Enough is enough! Recall Shea and Carroll!

t the end of 2019, a coalition of veterans, longtime Trvine residents, and university community members joined together to serve a "Notice of Intention" to circulate recall petitions to remove Mayor Christina Shea and Councilmember Michael Carroll from office for a variety of reasons. Neither Shea nor Carroll were elected to the positions they currently hold on the Irvine City Council. Both have angered Irvine voters with their relentless efforts to defeat the long-planned Veterans Memorial Park & Cemetery at the original 125-acre, City-owned "ARDA" site in the Great Park. Moreover,

Shea and Carroll have been working to enable developer FivePoint to gain control of the property for massive office, commercial, and industrial development, despite strong resident opposition.

For some weeks now, Irvine Community News & Views has been asking our readers to weigh-in on the proposed recall by participating in our online Irvine Community Poll.

When asked if they favor recalling and removing from office Mayor Christina Shea and Councilmember Michael Carroll, 500+ respondents expressed overwhelming support for the recall of the two: 90% said YES to recall Shea; 89% said YES to recall Carroll.

In addition to taking the poll, the community has been offering a surprising number of comments explaining why they support the recall. Only a handful of residents have opposed the recall and left a comment in support of Shea and Carroll. 
